


Revised Election Schedule: 2015-2016

| N.B: | Nomination papers were received up to 13.05.2015, but it was suspended from 14.05.2015 to 20.05.2015 because of a Status Quo imposed by the 4 th court of Assistant Judge Dhaka. Then after vacating the Status Quo by the Honorable Court on 20.05.2015 the normal functioning of the CEC has been restored from 06:45 pm of the same day(20.05.2015). |

| 6. | Completion of security of nomination papers by the CEC- 7 th June, 2015. |
| 7. | Publication of 1 st provisional list of candidates by the CEC-10 th June,2015 (30.03.04) |
| 8. | Last date of submission of appeal, if any, against the 1 st provisional list of candidates-14 th June, 2015, 8.00pm (30.03.05) |
| 9. | Finalizing the location of polling stations-by the CEC which shall not be at any place other than an established Centre/Sub-Centre of The institution-4 th June, 2015. (30.03.13) |
| 10. | Disposal of appeal against 1 st provisional list if any by -17 th June, 2015 (30.03.06) |
| 11. | Publication of 2 nd Provisional list of candidates on 21 st June, 2015 (30.03.07) |
| 12. | Last date of submission of appeal if any against the 2 nd provisional list 23 rd June, 2015 (30.03.08) |
| 13. | If needed changing Voting Centre with a certification from the Chairman or Honorary Secretary of his original Centre/Sub-Centre about the transfer and voter number by-5 th July, 2015 (30.03.14) |

| 25. | Date & time of polling- 3 rd September, 2015 from 9.00 am to 5:00 pm (nonstop) (30.03.19) |
| 26. | The Chairman of the CEC shall forward the consolidated official results along with all relevant documents to the HGS latest by 9 th September, 2015 who will then place the same before the Council. (30.04) |
